ORDER

Provisional recognition is granted to D.A.V. Public School, Sector 8-C, Chandigarh upto Senior Secondary level (Class XII) for three years i.e. from 01.04.2022 to 31.03.2025 under Article 235 read with 241-A of Punjab Education Code subject to the condition that the school should ensure that all the conditions as given below are complied within <u>six months</u> before the expiry of the extended period of recognition failing which further recognition would not be considered:

- Provisions of RTE Act and other instructions issued by the Education Department related to admission of students under EWS category and disadvantages groups be followed in letter and spirit (wherever applicable);
- 2. School will follow the provision of Rules of Recognition of Punjab Education Code;
- 3. School will follow land allotment conditions and other by the Chandigarh notifications/orders/ instructions issued Administration from time to time;
- 4. Managing Committee will be got approved from the Department;
- 5. Salary to the staff be paid as per the CBSE Affiliation Bye Laws;
- 6. Reserve fund be pledged as made applicable from time to time;
- 7. No particular book shop be prescribed for purchase of book/uniform etc. by the school;
- 8. Instructions/guidelines issued by CBSE relating to books/uniforms are to be followed;
- 9. Fire Safety norms be followed meticulously and there should be no laxity in this regard on the part of school;
- 10. Fee should be charged from the students as per CBSE Affiliation Bye Laws and receipt be issued to the students against the money charged from them;
- 11. Staff engaged should be fully qualified and untrained teachers should be replaced with trained ones;
- 12. Recognition is liable to withdrawn if the Management or the staff of the school take part in agitation directed against the authority of Government, or disseminate opinions tending to excite feelings of disloyalty or disaffection against Government or of enmity and hatred between different classes or if the pupils are permitted to attend political meetings or to engage in any form of political or communal agitation;
- 13. Government reserves the right, to grant, refuse or withdraw recognition at its entire discretion:
- 14. School will recruit teachers as per NCTE notification dated 12.11.2014 regarding minimum qualification of teachers including the qualifications prescribed for teachers at pre primary level as per letter dated 2.4.2018;
- 15. Building should be made Physically Challenged friendly and barrier free toilets should be provided to the students.

The recognition is also subject to the following conditions:-

- a) School Managing Committee must be approved by Education Department, Chandigarh Department.
- b) The School authority shall submit a copy of Income & Expenditure report and Balance Sheet for the years 2018-19 to 2021-22.
- c) Admission of 25% EWS students and Disadvantaged group be made upto class 8th under RTE Act, 2009 and admission of 15% EWS students from class 9th to 12th be made as per land allotment obligatory clause at Sr. No. 23 of allotment letter (provisions of Capital of Punjab(Dev. & Reg.) Act, 1952.
- d) The Contract of service between management and staff be followed.
- e) Fire Fighting equipments system should be in working order and fire safety certificate must be got received from the Municipal Corporation, Chandigarh immediately and copy of the same be submitted to this office.
- f) Income & Expenditure report and Balance Sheet.
